With these understandings, the undersigned owner/operator hereby elects to participate in the CCGC to meet the groundwater monitoring requirements contained in the Orders, and hereby elects to comply with such requirements accordingly. Owner/ Operator understands that voluntary participation in the CCGC only provides for compliance of the groundwater monitoring provisions of the Orders and does not substitute for compliance with any other provisions contained in the Orders. Owner/operator understands that membership dues are charged to cover the cost of administering the CCGC activities required to fulfill obligations contained in the Orders specifically associated with groundwater monitoring requirements. A detailed accounting of activities covered by these membership dues will be made available to members periodically, and are available to all CCGC members on request. Owner/Operator upon ten (10) days prior written notice to CCGC may withdraw its election to participate. Upon withdrawal, Owner/Operator will no longer be entitled to coverage as member of the CCGC.
